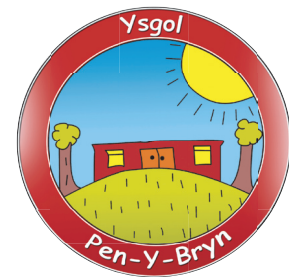




Contractors ID, Authorisation to Work Register

Important Notice to all Contractors



By signing our Authorisation to Work Register, you accept responsibility for complying with our Health and Safety regulations whilst on our site. Only the authorised work is to be carried out.

Your Contractor's Pass must be worn at all times. You must also retain your Authorisation to Work and any accompanying Permits-to-Work at all times.

On leaving our site your Authorisation to Work and Pass must be returned to the point of issue.

You must also sign the Authorisation to Work register to confirm that you have left the area in a safe and tidy condition.

- Notice to Contractors**
- Contractors shall comply with all relevant Health and Safety Law and Company Health and Safety Rules, and provide copies of current Public and Employer Liability Insurance and a Method Statement on request.
 - All persons within your control shall be competent to undertake their work safely.
 - A safe system of work shall be agreed with your contact before any work commences and may not be changed without his or her prior permission.
 - Contractors are responsible for making sure that all persons under their control know the fire procedures for the premises and the location of the appropriate type of portable fire appliance nearest to their work area.
 - The normal means of escape must not be obstructed without prior permission from your contact, who will make temporary alternative arrangements.
 - The following 'high risk' activities are subject to a permit to work: Hot work, demolition, excavation, asbestos, confined spaces, electrical work above 240V, overhead work, other specified work.
 - Faulty tools and equipment must not be brought onto site.
 - 110V CTE electrical tools are preferred. If 240V tools are used, they must be double insulated and RCD protected. All extension leads must be properly terminated with the appropriate plugs / sockets and be otherwise unjointed.
 - All portable and transportable electrical equipment: pressure systems and climbing safety equipment shall be within their current safety certification period.
 - Suitable Personal Protective Equipment shall be worn when necessary and must be within certification period.
 - Contractors should view the organisation's Asbestos Register before commencing work. If, for whatever reason, this register is not available, Contractors should assume that asbestos is present.
 - This building is subject to COSHH regulations.

Your signature on receipt confirms that you have read and understood the health and safety notes on both the front and reverse of your Authorisation to Work, and that you agree to abide by all our policies and regulations.
